By signing the waiver and agreement to hold harmless, you agree to the following:

This is a binding contract between Camp Woof of Norcross LLC d/b/a Camp Woof (hereafter called "Camp Woof" and the dog owner (hereafter called "Guardian).

Camp Woof will exercise reasonable care to any and all dogs staying at Camp Woof. However, Guardian understands that participation and boarding at Camp Woof is not without some risk. While under the care of Camp Woof, Guardian agrees to be solely responsible for any and all acts of Guardian's dog's/dogs' behavior. Guardian assumes any expenses and liability for injuries to dog(s) and/or persons while at Camp Woof. In addition, Guardian agrees to pay any and all medical and/or veterinary expenses incurred as a result of any injury inflicted by Guardian's dog(s) to another person or dog(s) while under the care of Camp Woof. Guardian gives Camp Woof sole discretion to act on Guardian's behalf in electing whether or not to seek veterinarian care for Guardian's dog(s) at Guardian's expense. Guardian hereby waives and releases Camp Woof, its employees, owners, and agents from any and all claims, while on the grounds or the surrounding area, and resulting from participation at Camp Woof including specifically, but not limited to, any injury or damage resulting from the action to dog(s).

Camp Woof Policies

- All dogs must be spayed or neutered once they reach seven (7) months of age. Dogs that do not meet these requirements may be kenneled in a separate area and will not join in the play groups.
- All dogs should be in general good health, at least three (3) months of age, and must have completed all series of shots prior to registering with Camp Woof. Dogs must not have been exposed to any illnesses within a thirty (30) day period prior to a visit at Camp Woof. We must have a copy of your dog's/dogs' most recent vaccination records prior to your dog(s) attending daycare or boarding.
- All dogs must be free of fleas and ticks. We reserve the right to treat any dog brought into Camp Woof for fleas and ticks at the expense of the Guardian.
- When boarding your dog(s), we ask that you bring your dog's/dogs' usual food to minimize diet disruptions. Otherwise a \$3/meal fee will be charged for our food.
- All dogs are required to attend a day of daycare before a boarding reservation can be made. This allows us to determine if your dog's/dogs' personality/personalities and behavior are compatible with our free-roaming playroom environment. This maybe waived by the manager of the facility.
- Camp Woof reserves the right to limit your dog's/dogs' playtime if he/she appears to be overly tired or over-stimulated, and/or exhibit any other behavior(s) that might act as a detriment to your dog's/dogs' health and well-being or that of any other dog staying at Camp Woof. Should inappropriate behavior occur, the Camp Woof staff shall manage that behavior as deemed necessary.
- Camp Woof reserves the right to refuse service to any customer or dog(s) at any time for any reason or to restrict any pet from daycare and/or boarding for any reason.
- Daycare packages, boarding packages, bath packages, and brush-out packages are non-refundable and are not transferable.
- Boarding requires a reservation. You may pick up or drop off your dog(s) at any time between 7:00 am and 7:00 pm. Dogs left for grooming and/or daycare that are not picked up by 7:00 pm will be charged a day of daycare and an associated night of boarding.
- Boarding rates are by the night, we do not charge any late fees. We do suggest drop off before 12:00 pm so your dog can get acclimated to our facility.
- Daycare fees cover 7:00 am – 7:00 pm. If you do not pick up your dog(s) by 7:15 pm, we will provide overnight boarding at your expense. We will charge a \$10.00 late pickup fee per dog for daycare dogs picked up after 7:00 pm and before 7:15 pm.
- A 24-hour cancellation notice is required for non-holiday boarding reservations. If we do not receive a 24-notice, then one night's boarding fee will be assessed.
- Holiday boarding reservations require a 72-hour cancellation notice. If we do not receive a 72-hour notice, then one night's boarding fee will be assessed. Once a holiday reservation has begun, a fee of \$10/night (per dog) will be assessed if you end up shortening the reservation. A one (1) night deposit will be required for all holiday reservations. This deposit is fully refundable if the reservation is cancelled 72-hours ahead of the expected arrival date.
- A \$3.00 per night holiday surcharge will be charged three (3) days before and after the following holidays: New Years Eve, Memorial Day, July 4th, Labor Day, Thanksgiving and Christmas.
- Prior to your dog(s) leaving our facility, all daycare/boarding/bath and/or incidental charges incurred during your dog's/dogs' visit must be paid in full.
- Checks returned by your bank will be accessed a returned check fee charged by our bank.
- A credit card number is necessary in order to enroll your dog in daycare or boarding. Your credit card will be charged in the event your dog(s) requires medical attention or if we receive a non-sufficient funds check. Should that occur, you would be asked to pay by cash or credit card for future services.
- Camp Woof reserves the right to change our policies at any time without prior notice.
